**MINI TRIAL:** Dressage will be ridden in Small Arena (20 meters x 40 meters), sand footing. Stadium: 8-12 jumps in fenced sand arena. **Cross Country:** Flat course for all levels, good footing and great for beginners or as a move up course.

**ATTIRE:** Formal attire not required. Approved helmet required at all times when mounted. Medical armbands required when jumping and protective vests are required on cross country.

**STABLING:** Very limited on site stabling is available for \$30 a night. Please contact Debbie lezzi for availability. Must clean out stalls upon departure.
